Mr Andrew LIU

aged 46, has been a Director since 1977. He is the Chief Executive Officer of JP Morgan Partners Asia. Mr Liu, holder of a Master of Arts degree from the Oxford University in England, was a solicitor with Slaughter and May in London before joining Morgan Stanley & Co Inc in New York in 1981. Mr Liu was promoted to Managing Director in 1990 before relocating to Morgan Stanley Asia Limited in Hong Kong, where he assumed the position of President and Managing Director until his resignation in September 1997. Mr Liu remains associated with Morgan Stanley as an Advisory Director. He was an Executive Director of the Bank between September 1997 and May 1999.
