- 3. Outstanding principal amount of the loan is calculated according to the formula known as the "Rule of 78". The "Rule of 78" is the calculation of the interest and principal repayment and the allocation of the two components. In principle, customer's repayment will be utilised to settle the interest prior to the principal. A larger proportion of the repayment made in the early stages is allocated to settle the interest and finance charges, with a smaller proportion to repay the principal. Such allocation of the repayment will reverse after more instalments have been made while the total interest expenses will remain unchanged. The Bank reserves the right at its discretion to apportion the monthly repayment amount of the loan.
