Notice of Amendments to Chong Hing Credit Card Key Facts Statement, Chong Hing Credit Card Charges Table and Chong Hing UnionPay Dual Currency Credit Card Charges Table

With effect from 24 June 2025, Chong Hing Credit Card Key Facts Statement ("KFS") of Chong Hing Bank Limited (the "Bank") will be updated. The relevant new / revised contents are as follows:

1. Product Disclaimer	This product is a credit card. This KFS provides you with indicative information about interest, fees and charges of this product but please refer to Chong Hing Credit Card Cardholder Agreement, Chong Hing UnionPay Dual Currency Credit Card Cardholder Agreement, Chong Hing Credit Card Charges Table and Chong Hing UnionPay Dual Currency Credit Card Charges Table of the Bank for details. Please read and understand the information in this KFS before you apply for this product. You will be requested to confirm that you have read and understood the information in this KFS when submitting the application.	
2. Interest Rate for Retail Purchase	22.8% per annum for Mastercards (Titanium / Platinum) / 32.16% per annum for UnionPay Dual Currency Credit Card, VISA Cards and other Mastercards when you open your account and it will be reviewed from time to time.	
3. Interest Rate for Cash Advance	22.8% per annum for Mastercards (Titanium / Platinum) / 29.52% per annum for UnionPay Dual Currency Credit Card, VISA Cards and other Mastercards when you open your account and it will be reviewed from time to time. Interest will be charged on the amount of cash advance from the respective dates of advance until the date of repayment of the advanced amount(s).	
4. Remark	The Chinese version of this KFS is for reference only. The English version will prevail if there is any inconsistency between the English and Chinese versions.	
5. Other Adaptive Amendments	Adaptive amendments to the product name of credit cards and the layout of KFS.

[#] Add the explanation of Interest Rate for Retail Purchase in Chong Hing Credit Card Charges Table and Chong Hing UnionPay Dual Currency Credit Card Charges Table at the same time: The Bank will not charge customers interest if customers pay his/her balance in full by the due date each month. Otherwise, interest will be charged on (i) the daily unpaid balance (whether due or not) from the statement date until the outstanding amount of the statement balance is repaid in full; and (ii) the amount of all new transactions (other than cash advance, in which case the finance charge is calculated from the date of advance) from the date of respective posting dates of the new transactions, notwithstanding that any such new transactions amounts are not due for payment, until all outstanding balance in respect of the card account is settled in full.

- * The APR is calculated based on the requirement of the Code of Banking Practice. APR is a reference rate which expresses the fees and charges of respective products as an annualised rate.
- If the investigation result shows that the transaction(s) is/are proved to have been authorised and performed by the cardholder, the Bank will charge a Dispute Transaction Handling Fee.

Please note that all the above-mentioned amendments shall be binding on you if you continue to use or retain the Bank's credit card(s) on or after the aforementioned respective effective dates. If you do not accept the above amendments, the Bank will not be able to continue to provide these credit card services to you, please contact the Bank' before the aforementioned respective effective dates.
